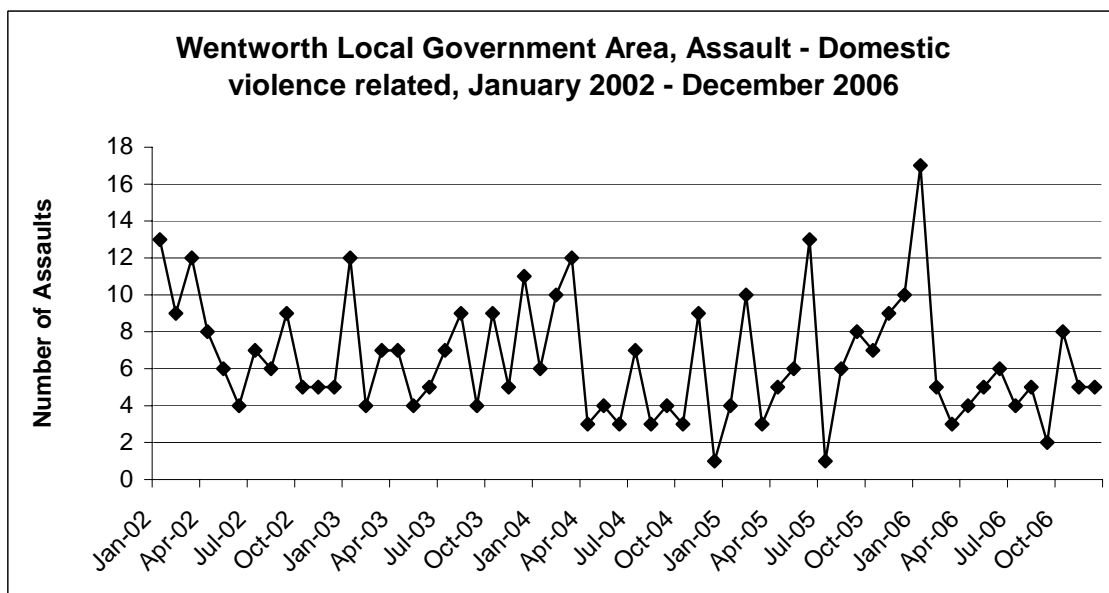
Wentworth Draft Crime Prevention Plan

The Bureau of Crime Statistics and Research (BOCSAR)'s most recent figures indicate that Family and Domestic Violence and Break and Enter – Dwelling are the priority offences within the Wentworth LGA.

Wentworth LGA ranked 9th in New South Wales for Assault (Family and Domestic Violence related) in 2006, which is a slight improvement from 5th in 2005. Wentworth LGA ranked 3rd in New South Wales for Break and Enter (Dwelling) in 2006 compared to 16th in 2005, which reflects a strong upward trend in break and enter offences. These two offences have been nominated as the priority focus areas of the 2006-09 Wentworth Crime Prevention Plan.

Priority 1 - Domestic Violence

- There were 69 incidents of Family and Domestic violence in the 2006 calendar year.
- Wentworth LGA was ranked 9th in New South Wales for family and domestic violence in 2006, with a rate of 945.2 per 100,000 population.
- There were only 34 Family and Domestic Violence Related Apprehended Violence Orders issued within Wentworth LGA during 2005.
- The Murray Statistical Division to which Wentworth belongs has the second lowest rate for granting of AVOs in the state
- Breach of apprehended violence orders has remained stable over the last 5 years
- The rate of offending has been stable over the past 5 years
- There are currently limited services available for victims of family and domestic violence, within Wentworth LGA
- There is limited Court Assistance Service for victims of family and domestic violence within the Wentworth LGA

Consultations indicated that there is limited support for victims and survivors of Family Violence and Domestic Violence in the Local Government area. There is some support from Indigenous Family Violence Prevention Legal Services including limited Court assistance since 2005. Their offices are located in Dareton and Buronga and have recently established an outreach centre in Wentworth. In addition the Murray Mallee Community Legal Service has assisted since 1996 and can provide some assistance to NSW residents. Support services are also offered by the NSW Police DVLO.

The statistical information used regarding the level of violence could well be understated as these groups have identified that the problem is of much greater concern than the number of incidents reported. Research (including the most recent Commonwealth Women's Safety Survey) suggests that only about 20% of all Family Violence or Domestic Violence is reported to the Police.

Concerns were also raised regarding the accuracy of statistics about granting of AVO's. NSW Police have been required to apply for AVO's when attending Family Violence incidents for some time, and the Wentworth region Police Prosecutors have adopted a pro-prosecution policy for many years. Since March 2007, Magistrates have been required to issue AVO's whenever there is a charge of assault laid in a family situation, which formalizes the practice already in use by the Wentworth Court.

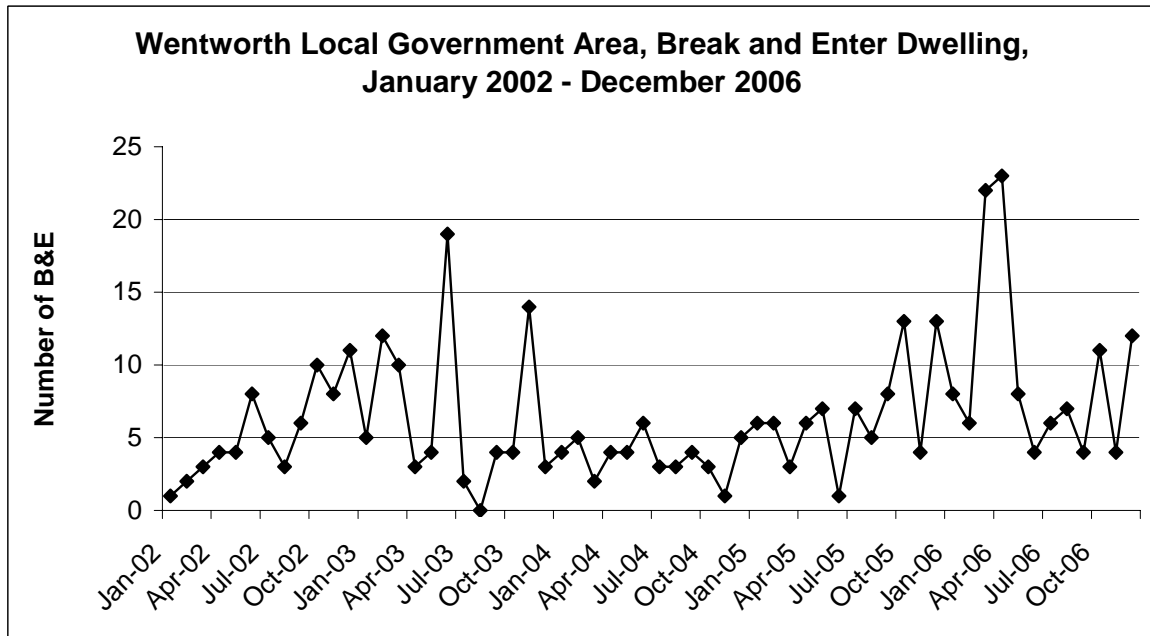
The Statistics up to December 2006 indicate the need for improved services provision is further articulated by the fact that Wentworth has a high rate for reporting of domestic violence but a low rate for granting of AVOs but statistics are likely to change in the next update. This suggests victims are not being supported to take legal action against perpetrators and are probably remaining in situations of violence and abuse.

It was recognized that two existing youth crime prevention projects, Moopra Noogas and Our Journey to Respect, funded through Council's Safer Community Compact grant, aimed to raise awareness of domestic violence and respectful relationships with young Aboriginal men and women. These projects need to be sustained, but other strategies are needed to educate the broader community about issues such as Apprehended Violence Orders and legal rights and support options relating to domestic violence.

Priority 2 - Break and Enter –Dwelling

- There were 115 Break and Enter Dwelling Offences within Wentworth LGA in the 2006 calendar year.
- Wentworth LGA is ranked 3rd in New South Wales for Break and Enter Dwelling Offences with a rate of 1575.3 offences per 100,000 population.
- There was a **176%** increase in Break and Enter Dwelling offences between December 2001 and December 2006.

Consultations were carried out with Police and the Dareton/Wentworth Crime Prevention Committee.

Police advised that the majority of break and enter offences were committed in Dareton, with most offences attributed to children in search of food, through normal school hours and by serial non-attendees of school. Generally, the items stolen were food and small change, as opposed to valuables. Small footprints were identified at some houses that had been entered, and in some instances, the point of entry was so small that only a child could have accessed the premises.

The owner of the Dareton Convenience Store supported this suggestion, advising that children approach the store seeking free food on a nightly basis. Staff of the Aboriginal Community Patrol also indicated that a number of children experienced neglect, which they accredited to problem gambling. A range of community members and service providers on the Wentworth Council Crime Prevention Committee reinforced this perception.

It was agreed that the Crime Prevention Plan should address the motivation for theft (i.e. child neglect) as well as making the offence harder to commit. There was agreement that funding should be sought for a night-time support service where young people could access food and support. The supervisors of such a space could then make referrals to local child and family services. Council has since negotiated access to the vacant Guides Hall as a venue for this service.

There was also support for security audits to be conducted in streets most commonly targeted for break and enter. Division and NSW Police staff will conduct the audits, and support sought from local services to enable free or subsidised access to home security improvements. Good practice personal, home and vehicle security fact sheets will be locally distributed and promoted by local service providers and media.

Note: Further consultation with the Dareton Wentworth Aboriginal Community Working Party has been scheduled for 15 March 2007.

Evaluation of the Wentworth Crime Prevention Plan:

Family and Domestic violence strategies.

After 12 months of the plans implementation Wentworth Shire Council will evaluate the effectiveness of the implementation of strategies, using a comparative analysis of the following indicators:

- Number of reported domestic violence related assaults
- Rates of reported domestic violence related assaults per 100,000 pop
- Number of AVOs issued
- Rate of AVOs issued per 100,000 population
- Rates of legal action for breach of AVO
- Reduction in re-offending rates
- Rate of child protection reports per 1000 children aged 0-17
- Rate of children assessed as abused or neglected by type of abuse or neglect.

Wentworth Shire Council will also evaluate if victims of domestic violence are satisfied with the quality, accessibility and timeliness of local services. This will be measured through conducting surveys with consenting clients using the following indicators:

- Increased community confidence in services
- Increased community knowledge of services
- Increased community knowledge of legal processes.

Break and Enter

After 12 months of the plans implementation Wentworth Shire Council will also evaluate the impact that the break and enter strategies have had on the target offence. The target is a 10% decrease within two years, and a 20% decrease within two years in targeted hotspots identified by NSW Police. This will be measured by analysing:

- The gross number of break and enter offences across the LGA
- The gross number of offences in area hot spots

When evaluating this information Wentworth Shire Council will also consider if the strategies had an impact on malicious damage to property offences, as the enhancements to environmental design (through the CPTED upgrades) may have a positive impact on these types of offences.

Wentworth Shire Council will also consider if offending has been displaced to other areas of the LGA due to the increased focus on area hot spots and situational crime prevention strategies. The evaluation will also consider whether strategies have caused an increase in other types of theft offences.
