NSW/VIC BORDER UPDATE

People who live in a border community do not need a permit to travel, but must carry a valid form of photographic ID with a current address when travelling.

Residents from the border bubble who have been into New South Wales beyond the bubble area in the past 14 days will not be able to cross the border from New South Wales into Victoria – but provided they meet this criteria, both New South Wales and Victorian border residents are able to travel as they would for their normal day to day activities like work, shopping and eating out.

There are no restrictions on New South Wales border bubble residents travel within Victoria if they have not travelled north of the bubble border, but it is recommended that travel only be as far into Victoria as necessary.

NSW/SOUTH AUSTRALIA BORDER UPDATE

As of 14 January 2021, the following restrictions now apply to travel between New South Wales and South Australia.

The following areas of New South Wales are now declared Prohibited locations: Greater Sydney Region, Wollongong Local Government Area and Central Coast Local Government Area.

Travellers are not permitted to travel to South Australia from the above areas unless they are an essential traveller or an exempt person.

Travellers may travel to South Australia from all areas of New South Wales outside of the above areas, but must submit to a COVID-19 test on day 1, 5 and 12.

USE OF THE MURRAY RIVER

Border community residents can use the Murray River for recreational purposes as part of the Cross Border Community area.

NSW residents, outside of the Cross Border Community area can use the Murray River and should avoid disembarking on the southern bank. Should residents need to disembark, they must stay below the top of the river bank and should not mingle with Victorian residents. Victorian residents are not permitted to board a boat with NSW residents who reside outside of the border community region.
