

## Project EnergyConnect Construction Update

August 2022

### **Work Outside Approved Construction Hours**

We are writing to update you on work outside approved construction hours on EnergyConnect, Australia's largest transmission project. The project will connect electrical grids across Australia and will improve reliability of our nation's energy supply.

SecureEnergy Joint Venture has been contracted by Transgrid to deliver part of EnergyConnect with the construction of 700km of new power lines from the SA border to the regional energy hub of Wagga (refer Image 1). The project is due to be completed by 2024.

As part of EnergyConnect we will be building access points to new overhead transmission lines and water points, several camps and laydown areas located along the project alignment to accommodate our construction crews and staff, and the extension of two substations (Buronga and Wagga Wagga) and a new substation at Dinawan (Coleambally).

### As part of building the EnergyConnect project, we will be working outside approved construction hours.

### Work hours

Typically work will be carried out during the project's approved construction hours, which are:

- Monday to Friday 7am-6pm
- Saturday 8 am to 1 pm
- At no time on Sundays and NSW Public Holidays

#### Why do we need to work outside approved construction hours?

Out of hours works are required so we can minimise the impacts of noise on residents and the community. If we can work extended hours during our construction activities, it will take less time to build EnergyConnect and the overall noise impacts will be reduced.

### How we manage our work

The Project Team will use machinery that generates noise, light and vibration. To manage this work, we will:

- Minimise the number of plant/vehicles to be used
- Ensure all plant/vehicles to be maintained and serviced
- Turn off machinery when not in use
- Undertake the majority of works during daylight hours however if lighting is required, direct temporary lighting down and away from residents
- Fit equipment with devices to minimise noise, particularly reversing squawkers will be used where reasonably practicable
- Monitor noise so we can manage any potential impacts and adjust our work as required
- Use watercarts for dust suppression

All work will be carried out in line with the project's Conditions of Approval and the Construction Environmental Management Plan.




Image 1: EnergyConnect map of the alignment
