*(18 years of age or over on 26 January 2025)*

- Significant contribution to the community
- An inspirational role model for the Australian community
- Information about the impact the individual's contribution has on the local government area

#### Young Citizen of the Year

*(Under 18 years of age on 26 January 2025)*

- Significant contribution to the community
- An inspirational role model for the Australian community
- Information about the impact the individual's contribution has on the local government area

#### Sportsperson of the Year

*(18 years of age or over on 26 January 2025)*

- Outstanding sporting achievement conducted in the spirit of fair sportsmanship

#### Young Sportsperson of the Year

*(Under 18 years of age on 26 January 2025)*

- Outstanding sporting achievement conducted in the spirit of fair sportsmanship

#### Environmental Award

*(Individuals or groups)*

- Has made a positive impact on our local environment through innovation or volunteer work to improve our waterways, our flora or fauna and our natural surrounds
- Innovative use of the Return and Earn scheme to fundraise for a meaningful cause
- Fostering partnerships that achieve litter reduction and recycling outcomes
